CUSTOMS – WE SOLVE ALL KINDS OF CUSTOMS RELATED JOBS

Shipping.dk has its own customs department manned by committed staff who care about solving every job to the satisfaction of both clients and SKAT (the Danish tax authorities). We have dealt in customs matters since Told & SKAT (the Danish customs and tax authorities) became a known authority in Denmark. Before our company got the name Shipping.dk we were approved for import (1973) and export (1979). Within the past 10 years we have intensified our focus in this area.

In connection with all import and export customs procedures it is required that the companies have the approvals and registrations required by law. If the company does not have those we can be of assistance in sorting out these matters.

We work in several systems: KSD for T document and SKAT's own online systems.

We stay updated continuously i.e. as member of The Danish Shipbrokers' Association and The Danish Shipowners' Association committees consisting of members from shipbrokers and shipping companies. Here we are in close communication with SKAT and work on influencing the correction of faults and wants in SKAT's systems as well as being updated on the systems and new initiatives, laws and regulations with respect to these systems.

As a rule we can assist in everything connected with SKAT, the Danish Business Authority, The Danish AgriFish Agency (Ministry of Food, Agriculture and Fisheries of Denmark) as well as import and export of goods.

Shipping.dk has bonded warehouses in Kalundborg, Frederikshavn and Fredericia – and soon also in Middelfart. Furthermore, we have approved exporter permit as well as permission for FUE, MIO, FOE and MIG.

It is a legal requirement that importers and exporters keep themselves informed about the laws and regulations in force but no matter what kind of task we are talking about we always assist in guiding and finding the best solution whether it has to do with export or import.
